



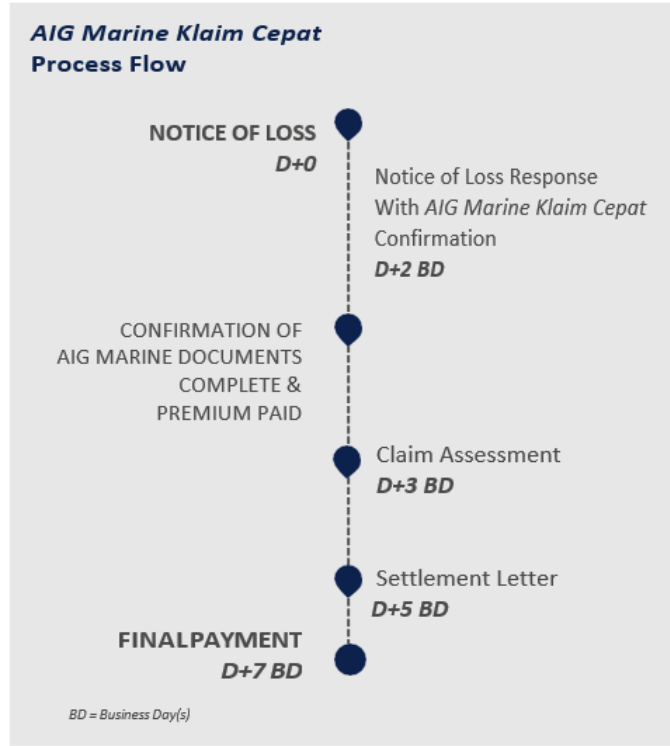

## AIG Marine Klaim Cepat

### Included:

- 1<sup>st</sup> party cargo claims
- 3rd Party Cargo – Pre-Determined / Agreed Liability
- AIG as Insurer 100% share or as Leader
- Claim Amount ≤ USD 5,000 (net of deductible)

### Excluded:

- All others

- Complete [General](#) and [Specific](#) Claim Forms signed by authorized person
- Copy of Bill of Lading/ Airway Bill/Waybill
- Copy of Delivery Receipt
- Copy of Commercial Invoice

## AIG Marine Klaim Cepat Values for Better Experience

AIG Marine Klaim Cepat	Regular Claims
➢ Only requires 4 claims documents.	➢ Requires 8 or more claim documents
➢ Discharge letter is not required	➢ Discharge letter is required
➢ Claim Payment 7 days from Notice of Loss date (if complete documents received on notice of loss date and premium fully paid)	➢ Settlement offered 14 days from completion of document and premium paid (whichever the latest)

note: if premium is still not fully paid until all AIG Marine Klaim Cepat documents are completed, claims will not be considered as AIG Marine Klaim Cepat

*Disclaimer: AIG reserve the rights to determine the claims as AIG Marine Klaim Cepat or regular claims. AIG Marine Klaim Cepat with incomplete documents will be closed after 45 days since notice of loss date. Client may re-submit the claim and will be considered as a new regular claim.*
