Child Guard

- Medical Report
- Birth Certificate
- Original Receipt of Airfare/ Rail/ Sea Transport/ Accomodation

Travel Interuption

- Proof of hospitalization more than 5 days
- Medical Report
- Original Invoice & Receipt from Travel Agent and Statement showing breakdown of tour package and refunded amount

Automatic Extention of Policy

- Proof of Hospitalization/ Quarantine

Accindental Death and Permanent Disablement

- Original Medical Report
- Original/Legalised Autopsy Result
- Original Police Report
- Original/Legalised Death Certificate
- X-Ray Result
- Statement from treating doctor on percentage of permanent disablement

Travel Cancellation

- Death Certificate/ Medical Report
- Original tour/ ticket/ hotel invoice & Receipt
- Refund confirmation from travel agent/ airlines/ hotel
- Proof of relationship to insured

Travel Postponement

- Death Certificate/ Medical Report
- Original tour/ ticket/ hotel invoice & Receipt
- Proof of administrative Charges of the postponement
- Proof of relationship to insured

Travel Curtailment

- Death Certificate/ Medical Report
- Original tour/ticket/hotel invoice & Receipt
- Refund confirmation from travel agent/ airlines/ hotel/ other party
- Proof of relationship to insured
- Original receipt of additional airticket and hotel

Baggage Delay

- Property Irregularity Report
- Baggage delivery receipt

Travel Interuption

- Medical Report
- Medical bills confirming insured hospitalized for more than five days
- Original tour/ transportation/ accomodation receipt
- Breakdown of unused portion from Travel Agent/ Tour Operator
- Proof of refund from Travel Agent/ Airlines/ Hotel/ Other Party

Baggage Delay

- Property Irregularity Report
- Baggage delivery receipt

Baggage Loss/ Damage

- Original Property Irregularity Report (if baggage loss or damage while in the possesion of Airlines)
- Original Damage Report from Other Common Carrier or Hotel
- Police Report (if baggage loss in public place)
- Letter of compensation from Airlines/ Hotel/ Other Party
- Original Purchases Receipt of loss items or other proof of ownership/warranty cards
- Repair bills
- Photograph of damage items

Flight Delay

- Delay statement from Airlines showing time and reason of the delay
- Airticket and boarding pass

Loss of Travel Document

- Original Police Report
- Original Receipt of additional travel or accommodation expenses for obtaining replacement of travel document
- Original Receipt of replacement cost of travel document

Travel Misconnection

- Statement from Airlines
- Itinerary and boarding pass

Rental Vehicle Excess

- Rental Vehicle Agreement
- Car Accident Report
- Receipt for Payment of excess
